50th Anniversary Sweepstakes Official Rules

Eligibility: No Purchase Necessary to enter or win. Making a purchase or payment of any kind, or membership in AmeriChoice Federal Credit Union (“AmeriChoice”) does not improve your chances to win. The AmeriChoice Federal Credit Union “50th Anniversary” Sweepstakes (the “Sweepstakes”) is open to anyone who: (i) follows these rules; (ii) qualifies for AmeriChoice membership and (iii) is 18 years of age or over as of March 1, 2020. Officers, directors, and employees of AmeriChoice Federal Credit Union and members of their immediate family or persons residing in their households are not eligible to win a prize. The Sweepstakes is void where prohibited by law. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. By participating in the Sweepstakes, you agree to the terms and conditions of these Official Rules.

New AmeriChoice members and existing members will automatically be entered in the Sweepstakes when they apply for a loan or open a new share draft account with AmeriChoice. -If an existing AmeriChoice member is already a primary account owner of a share draft account, the member will not automatically be entered for opening a new share draft account unless the member is only a joint owner of another member’s share draft account, or if the member applies for a loan with AmeriChoice. The Sweepstakes will run from 12:01 A.M. EST on March 1, 2020 and will end at 11:59 P.M. on November 30, 2020 (the “Promotional Period”).

Prizes: Five (5) prizes will be awarded in total. One (1) top prize of \$1,000 Cash and four (4) second prizes of \$100 Cash Cards will be awarded during the Promotional Period. All prizes are subject to availability and may be subject to change without prior notice. AmeriChoice reserves the right to substitute any prize with an item of equal or greater value.

Winners shall be responsible for payment of all applicable federal, state, and local taxes imposed on prizes and may be required, as a condition of receiving a prize, to provide AmeriChoice with their Social Security number so that reports may be filed with appropriate taxing authorities.

How to Enter: To win a prize, you are not required to be an AmeriChoice Member, purchase goods or services from AmeriChoice, to pay any money to AmeriChoice, or to submit to any sales promotion effort. You may enter the Sweepstakes any time during the Promotion Period. To enter without applying for a loan or opening a new share draft account, please include your name, address, daytime and evening phone numbers, email address, and date of birth on a 3" x 5" card and mail it in an envelope with proper postage, or personally deliver it, to “AmeriChoice Federal Credit Union, 50th Anniversary Sweepstakes”,

Attn: Marketing Department, 2175 Bumble Bee Hollow Road, Mechanicsburg, PA 17055. You will receive one (1) entry into the Sweepstakes. Limit: One (1) entry per envelope. All mail-in entries must be handwritten and must be postmarked by the end of the Promotional Period.

AmeriChoice assumes no responsibility for lost, late, incomplete, stolen, misdirected or fraudulent entries. All entries shall become the property of AmeriChoice and will not be returned. All entries have an equal chance of winning a prize. The odds of winning are dependent on the number of eligible entries received. You need not be present at the drawing to win.
